# 5. NEW WASTE TRANSPORT REGISTRATION REQUIREMENT.

Businesses across Suffolk could be faced with a fine of £300 fixed penalty up to £5,000 if they do not register as a waste carrier, broker or dealer from January, 2014. # COMMUNITY EMERGENCY PLANNING WORKSHOP.

Cllr. James Gorzelak reported that "Walsham-le-Willow fared much better than some parts of the country with regard to disruption caused by the recent storms.

Following the St. Jude storm roads were quickly cleared of falling trees and the coffee shop was held as an alternative venue. This showed the community spirit is alive and well in Walsham and I would like to thank you all for that.

I have not received notice of any significant issues due to flooding in the village as a result of recent heavy rains although the level of the stream rose significantly for a while. The flood meadows did their job and the continued efforts of keeping the stream clear also helped considerably, and finally, new developments in the village do not appear to have contributed significantly to either drainage requirements or surface water run-off. However, we cannot become complacent.

Regarding the roads, I am not aware of any significant flood issues in our parish. The repairs done to the Ixworth road have significantly reduced the formation of large puddles and flooding across the road. The Badwell road copes fairly well however continued flooding of the section between Badwell Ash and Hunston is of concern.
