COUNTY COUNCILLOR JESSICA FLEMING.

Railway Crossings and GEML Upgrades.

In Suffolk, Network Rail's Anglia route asset management team is starting to review the safety of all level crossings on the Great Eastern Main Line (GEML). Officers from Suffolk County Council's Transport Strategy Team and Rights of Way Team are working with Network Rail on this project. The work is being undertaken through the Suffolk Road Rail Partnership Group (SRRPG).

The County's position is that it wants to see safe level crossings and faster travel times, and also ensure that the public is properly consulted and accessibility is not compromised as part of the process. It will continue to respond robustly to Network Rail where proposals are not matched with appropriate access.

Consultation on Network Rail - Anglia Route Study - end date 3rd Feb.

This Route Study sets out how future growth in the long term to 2043 could be accommodated as well as the nearer term (2019 – 2024). Although no direct mention is made of crossings the public is encouraged to respond with any comments on these plans. http://www.networkrail.co.uk/long-term-planning-process/anglia-route-study

DFT Consultation on the new East Anglia Rail Franchise – end date 16th March. This document describes the DfT's planned approach for rail passenger services on the Greater Anglia franchise when the current contract ends on 16th October 2016.
