DISTRICT COUNCILLOR DEREK OSBORNE.

Cllr. Osborne has e-mailed stating that having been elected to represent the Rickinghall and Walsham Ward he feels that after 8 years representing Walsham and Wattisfield we all might like a change, therefore he has decided to hand over the reins here to his fellow Councillor Jessica Fleming, and he will be representing the 4 villages which Sara Michell used to look after. POLICE.

PCSO was not in attendance but sent the following report.

Crime Stats

Since your last meeting there has been 1 crime reported to the police. We cannot provide information for this.

Policing Precept

Police and Crime Commissioner, Tim Passmore announced today (Friday January 30th) that he will be asking council taxpayers to pay an average 6p a week extra towards policing in the county in the next financial year. The PCC presented his proposal to the Police and Crime Panel meeting at Suffolk County Council's HQ for their consideration, the panel unanimously supported the proposal.

For the past two years the policing element of Suffolk's council tax precept has been frozen but this year the PCC felt in view of the financial challenges we are facing and the enormous demand that the Constabulary is managing, he should implement a small increase of just less than 2%.

COMMUNITY SPEED WATCH.

We carried out a speed check by the Sports Club earlier this month. There were ten vehicles caught equal to or in excess of 36 mph, with the fastest at 51 mph.. The policy is for the Police to immediately visit owners/drivers of vehicles caught in excess of 50 mph once all appropriate checks have been completed.

PLAY AREA.

Owing to the fact the John Stebbing is no longer on Parish Council Cllr. Roberts has agreed to be the Play Area co-ordinator. The Clerk will inform Quentin Cass.

The Clerk reported that she had contacted David Smith who has agreed to repair and make good the fence.

With regard to the fallen tree the Play Council have agreed to pay half the cost of removing this,

FOOTPATH WARDEN.

Cllr. Belson had nothing to report but made a request for 24 'footpath discs'. The Clerk was instructed to obtain these.

CLERKS FINANCIAL REPORT AND REQUEST FOR PAYMENTS.

A report of income/expenditure against budget to the 30th April, 2015 was presented.

All cheques were passed for payment and duly signed.

The internal audit carried out by SALC has been completed.

MATTERS ARISING FROM THE COUNCIL MEETING HELD ON THE 14TH APRIL, 2015.

COMMUNITY PAY BACK TEAM – WORK WITHIN THE VILLAGE. No further progress. COMMUNITY EMERGENCY PLANNING WORKSHOP. A report from Sue Leake stated that

following the AGM I have 6 volunteers from different village organisations, who have agreed to be a part of bringing together the plan. I am away next week but will be calling a meeting on my return to complete the documentation. In addition, I will be doing an article for the next Observer.

LISTED BUILDING STATUS. Cllr. Belson is pursuing the issue.

FOUR ASHES TRIANGLE. Work on this **should** be carried out in conjunction with carriageway repairs in Crownland Road when the road will be closed from the junction with Badwell Road through to and including Crownland Road from the 26/5/2015 to 03/06/2015.

AFFORDABLE HOUSING Still awaiting the results of the survey.

WATER IN WATTISFIELD ROAD. Still ongoing.

SIGNS AT EACH END OF IXWORTH ROAD. Still awaiting action by Highways.

SALE OF SIX BELLS PUBLIC HOUSE. Mid Suffolk District Council have informed the Parish Council that they have accepted the nomination, submitted under the Community Right to Bid to list The Six Bells Inn at Summer Road as an asset of community value.

OTHER ITEMS FOR DISCUSSION.

RESTORATION OF GRAVE STONE IN CLOSED CHURCHYARD.

The Parish Council had no objections in principal to the work being carried out subject to the Council being informed of any work prior to commencement.

ANNUAL DONATION REVIEW.

SPEED GUN.

A request to Paul Leake, speed watch co-ordinator has been made for Stowlangtoft Parish Council to share the use of the speed gun. Obviously they would share whatever costs are involved and collect and return. The Parish Council had no objections in principal but requested that the Clerk checked on the insurance aspect and that any damage incurred whilst they are using it would have to be paid for.

CO-OPTION OF PARISH COUNCILLOR.

Mr. Brian Kinnair, Old Oak Barn, West Street, Walsham-le-Willows has applied to fill a vacancy by co-option to the Parish Council. It was proposed by Cllr. Bloomfield, seconded by Cllr. Barber and carried unanimously to co-opt Mr. Kinnair.

There is still one vacancy and the Clerk was instructed to advertise this in next month's Observer.
