COUNTY COUNCILLOR AND DISTRICT COUNCILLOR JESSICA FLEMING.

Prior to giving her County and District Council reports, Councillor Jessica Fleming informed Parish Council that the remaining £11,824 Section 106 monies from the Hopkins Homes development, earmarked for the Play Area, had been returned to the developers, upon their request as the time limit had been exceeded. Councillor Fleming has already asked for a full enquiry into the matter and will report back her findings as both Parish Council and the Play Council had been led to believe that there was a 10 year term limit to this agreement.
