COUNTY COUNCIL REPORT FOR WALSHAM-LE-WILLOWS.

COUNCIL BUDGET AND PRECEPTS FOR 2018/2018 – The Police and Crime Commissioner's Policing Precept will increase by 1.972% in 2017/18. Further detail of the precept and Panel report are available on the Suffolk County Council website.

There Will be a Mid Suffolk satellite office for public access in Stowmarket and the District is looking at ways of better using community facilities such as village halls for meetings as well.
