School Transport – A consultation about proposed changes to school transport commences on 12th December running until 28th February. The consultation seeks views on three alternative options for pre-and post-16 age groups. Please refer to: www.suffolk.gov.uk/schooltravel

Option 1: Change the school travel policy so that it is in line with the legal requirements starting in September 2019. Free travel would be limited to pupils' nearest suitable school.

Option 2: Introduce changes year by year as a child joins or moves school so that it is in line with legal requirements commencing in 2019, all changes would be phased.

Option 3: Make no changes to the school travel policy but make savings from other services provided by Suffolk County Council.

Ward Boundaries – Public consultation is now closed. The proposed new arrangement for the Walsham-le-Willows Ward assumes representation by 1 councillor along with Badwell Ash, Wattisfield, Great Ashfield, Langham and Hunston. Final recommendations will be considered by the Local Government Boundary Commission on 23rd January 2018 and published on 6th February 2018 with an Order made in March 2018

Planning Applications – Dates for determination remain to be decided for both Newhall Properties, Outline for 62 dwellings. 1352/17, and Evolution Town Planning, Land opposite Broad Meadows, Outline for 22 dwellings. DC/17/02783. SCC Highways has commented on recent re-submissions from both applicants and would support a 'hybrid' footpath link with details to be determined at reserve matters stage. Both will come before a planning committee, probably in around February.
