Boundary Review – The Boundary Commission review has been completed and the Commission's recommendations are that Mid Suffolk should be represented by 34 district councillors, six fewer than the current arrangements. The proposals also set out the names and boundaries of the eighteen one-councillor wards and eight two-councillor wards. For Babergh. The Commission proposes that the council should have 32 councillors in future: eleven fewer than now. The Commission will make its final determination in August 2018.
