New School Transport Policy (2019) - Children are eligible for SCC funded school travel if over 2 miles (under 8 years old) or 3 miles (aged 8 or over) walking distance from their nearest suitable school. Children already receiving SCC funded school travel in the 2018/2019 school year will continue to receive this whilst they continue to attend the same school for the same origin. Families with eligible child/ren should be notified but must opt-in by 31st May (2019) to receive funded transport. Major Infrastructure Consultations – The Cabinet at its 12<sup>th</sup> March meeting approved SCC's responses to (1) Consultation by Scottish Power Renewables on East Anglia Offshore Windfarms One (North) and onshore infrastructure including 2 major substations, and has objected to several elements of current plans. (2) EDF Energy's Sizewell C Stage 3 Public Consultation; SCC objects to several elements of current proposals including dropping the marine-led construction option, and elements of the rail and road-led options. The Council also has commented that the cumulativee effects of several major projects in East Suffolk need improved coordination at national level.
