MINUTES of meeting Tuesday 9th April 2019

1 FIRST BUSINESS

- 1.1 Apologies Cllr. Mecrow
- 1.2 Minutes of meeting held on March 12th were unanimously approved.
- 1.3 To receive pecuniary and non-pecuniary interests of members Cllr Ellis declared an interest with regard to discussion on tendering Play Area Maintenance work which might involve an approach to her partner.
- 1.4 To consider applications for dispensation Dispensation was unanimously granted by Council.
- 1.5 Public Open Forum Three members do the public present. Jean Davies from the History Group informed Councillor's of the intention of the new committee to provide a 'village recorder' as is required by the group's membership of the Suffolk Local History Council. The role of the recorder is to document the changes that take place in the village in an annual report. These reports are archived and form part of the documented history of the village. The Parish Council was asked to advise the history group of relevant changes that should be included. Jean also advised of plans to offer history group content currently recorded on CD's as digital downloads from the village website and for a small charge. The Clerk has already been contacted by the group re some other changes to the history group content.

Claire and Kevin Cornish appraised Councillors of their plans to develop a plot of land for their own use on The Avenue. Plans and documents were left with Councillors who suggested a check with solicitors about rights of way.
