NEIGHBOURHOOD WATCH

Suffolk Police are warning drivers about the consequences of filming collision scenes, as several motorists were caught offending during an incident in August.



Following a serious road traffic collision on the A14 - which resulted in the closure of one of the carriageways for several hours - seven motorists driving on the opposite carriageway were caught filming the collision scene as they drove past, four of whom were HGV drivers.

Their details were recorded by officers at the scene and they have all been issued with Traffic Offence Reports for driving without due care and attention.

It is illegal to use a handheld mobile phone whilst driving - or riding a motorcycle - and you must stay in control of your vehicle at all times. Police officers can stop you if they think you are not in control because you are distracted.

Motorists can be prosecuted if they are caught offending and the law still applies if you are:

-stopped at traffic lights

-queuing in traffic

-supervising a learner driver

The basic penalty for driving whilst using a mobile phone is a £200 fine and six points on your licence. Anyone who has passed their driving test in the last two years would lose their licence as a consequence of this.

Alternatively, you might be taken to court which could result in a driving ban and a maximum fine of \pounds 1,000 (or \pounds 2,500 if you are driving a lorry or bus).

Police are urging van owners to remain vigilant after in excess of 20 thefts and attempted thefts took place in West Suffolk, overnight between Wednesday 30 September and Thursday 1 October, in a variety of locations. The occupants of a white Audi estate car are suspected of being involved in these thefts.

If you have received an email which you're not quite sure about, forward it to the Suspicious Email Reporting Service (SERS): report@phishing.gov.uk.

The above is an example of a scam e mail a local resident forwarded to me. It purports to emanate from the HM Courts and Tribunals office, but one of the giveaways is that the e mail address, info@ticket.ma, has the country code which relates to Morocco. This has been reported as advised.

VILLAGE HALL UPDATE







- Parking on the Finningham Road blind bend & difficulty for passing traffic
- Available private parking spaces to Oak Tree Cottages & possibility of new spaces at front
- Traffic speed through that area (and the village generally)
- The non-adherence to the transport plan for the development on Wattisfield Road

The Parish Council has instigated engagement with County Cllr Jessica Fleming, District Cllr Rick Meyer, Flagship Housing, SCC Highways Safety Management, SCC Highways Traffic Surveys and the Planning Dept. This continues where it appears to be fruitful.

The not so good news...

- Reconfiguration of parking spaces to rear of Oak Tree Cottages or the provision of a layby and two new parking spaces to the front Flagship advised the reconfiguration of private parking spaces is not possible. The Parish Council thinks otherwise. SCC Highways indicated the potentially prohibitive costs of providing two more public parking spaces to the front of Oak Tree Cottages. SCC no longer have the resources to buy land from Flagship to achieve this and Flagship could give the land over to SCC if it so wished. Assessing the cost to the Parish Council budget is difficult because of the potential costs of identifying utility routes, re-routing them and/or protecting from vehicles likely to use the spaces above them. The area to be used would also also have to be levelled. As an example, a similar project in East Suffolk unexpectedly cost £40k.
- Moving the 30mph roundel further out on the Finningham Road to give earlier warning of the reduced speed limit sounds easy doesn't it? We have been advised that re-siting could cost in the region of £7000 £10,000 as it would require public consultation.
- Vegetation management around signage Highways advised the Parish Council must do this by means of a Community Self Help Scheme or by engaging its own contractors. Year on year budget cuts imposed by central government means the Local Authority no longer has the resources. The responsibility is pushed down to Parishes.

The better news...the Parish Council has not given up!



- **Speed Indicator Devices** –The Parish Council is pursuing the siting of further devices. Siting is problematical because stringent guidelines on placement limit the options. The Parish Council are required to interpret those rules and suggest locations which are then approved or rejected by the Local Authority. Four speed indicator locations were approved for two devices, part funded by SCC and Parish Council. Parish Council and the Sports Club volunteers move these between locations as well charging at their own expense.
- **Speed Surveys** There is no speed data from previous LA surveys. A speed survey has been requested at a cost of £585 plus vat to the Parish Council budget. Some parishioners have indicated a willingness to re-constitute the speed awareness team which surveys traffic with the Parish Council speed gun. If you would be willing to help in gathering more data, please make contact.
- **On-site meeting** The Parish Council has met with Cllr Jessica Fleming to illustrate the issues as it has been difficult to instigate a direct dialogue with Highways. Cllr Fleming will instigate an onsite meeting between Highways and the Parish Council to try to establish all the viable options and the costs involved. Some things that may be considered along with more speed indicator device locations, and the possibility of re-siting speed limit and village signage are 'village gates' and other traffic calming measures.

The long and short is that the Parish Council (parishioners) would be required to foot the bill for most changes through the precept levied on the Council Tax. Additional funding to reduce the burden on Council Tax is being pursued.

The Clerk who must administer any actions agreed by the Parish Council works approx. one day per week on Parish Council work. This is another limitation imposed by the Parish Council budget, ultimately funded through your Council Tax.



WALSHAM-LE-WILLOWS PARISH COUNCIL MEETING MINUTES

of the meeting held on Tuesday 13th October commencing at 7.00 p.m. Online via Zoom due to Coronavirus restrictions. Members of the public were able to join the meeting.

PRESENT Cllrs. Arbon, Bartholomew, Kinnair & Roberts. Cllrs Fleming & Meyer.

- 1 FIRST BUSINESS
- 1.1 Acceptance of apologies Clerk advised apologies from Cllr Ellis (who had advised she may join later) and Cllr Mecrow; both were accepted. Cllr Belson did briefly join the meeting but there were some technical difficulties that could not be resolved which meant that he was not present for the meeting.
- 1.2 **Minutes** of the meeting of held on 8th September 2020 were unanimously approved.
- 1.3 **To receive pecuniary and non-pecuniary interests** of members, none declared.
- 1.4 **To consider applications for dispensation,** none required.

1.5 **Public Open Forum**

.

A member of the public (MW) spoke to his email (and agenda item 5.1) re concerns about the letter that residents have received about the construction of a footpath with road narrowing and traffic calming from contractors associated with Lovells and the Wattisfield Road development and his assertion that "these plans have not previously been in the public domain". Parish Councillors answered his questions as best they could but felt that there was nothing new or unexpected. The Parish Council reassured that this concerns had all been discussed at length and addressed within the planning process as far as was possible, however unsatisfactory the outcome. Cllr Roberts sent some documentation which he felt would answer a lot of the questions. MW advised that he would read through and come back if he still had concerns that he felt were unanswered. He left the meeting at approx. 19:20

In the light of a district wide MSDC review of Sports and Leisure Facilities which might provide some opportunities, Ian Campbell presented, along with Cllr Meyer, the thinking on the future of the Sports Club which Cllr Meyer described as one of the most successful in the District. Cllr Meyer was keen to have a conversation with the Parish Council about its role vis a vis the place of the Sports Club in the Community. The club may be reaching the limits of what can be achieved with a team of volunteers. Bar income has been affected by the Corvid crisis, but it is hoped this will be temporary and the 'downtime' has been used for some refurbishments that allow for the possibility for more catering.

There are concerns that the Sports Club is well utilised at weekends but not nearly so well during the week. There were thoughts about possible relocation of the school in the longer term in the light of future housing development in the village. A thought was that a school closer to the sports club could benefit both and the village. It is thought from informal soundings that there is demand for more facilities at the club. The possibility for franchising certain activities has been discussed. Councillors raised concerns about possible competition between 'hub' spaces in the village which would need to be co-ordinated to ensure that all needs were served and felt that a formal consultation exercise should be carried out to ascertain demand. It was noted that the Neighbourhood Plan group will of course be looking at Sports and Leisure as a strand of the plan and would also be consulting widely on all aspects. Councillors were not sure what the role of the Parish Council would or should be in the future of the Sports Club other than being very appreciative of the benefits that the Club brings to the Community and supportive in whatever way it can be of anything that will ensure the Sports Club continues to thrive. Cllr Meyer is intending to push hard for the Club when he meets with MSDC. Cllr Fleming indicated her support for whatever transpires and noted that there will be funding coming through for 'Leisure and Fitness' initiatives.

1.6 **County and District Reports** – Cllrs Jessica Fleming & Rick Meyer presented their respective reports and invited questions and the full reports can be found on the village website at: https://www.walsham-le-willows.org/explore/governance-community/parish-council/

Cllr Meyer noted the good news of the imminent consultation on the Local Plan to be completed by the end of the year for implementation at the beginning of 2021. This will greatly assist the Neighbourhood Plan group in its work.

Cllr Bartholomew asked Cllr Fleming how she had responded to those people in the village complaining about traffic speed on the Finningham approach road into the village. The Clerk explained where things had got to in discussion with Highways re the possibility of a SID. Cllr Fleming offered to attend a site visit to try to identify a location as she thought that this had already been applied for. It was explained that the Highways guidelines make this look a very unlikely proposition and that the Clerk had been trying to engage them in a dialogue without success, rather than going through the standard application process only to have the location rejected. Also, the state of play on considerable potential costs to the Parish Council of having the 30mph limit moved out which may also provide a length of straighter road along which the location of a speed indicator device might be accepted. ACTION Clerk to liaise with Councillors and Cllr Fleming re a mutually agreeable date to hold the site visit.

Cllr Fleming will also look at the hedge /pavement on The Causeway [agenda item 4.6] during same site visit.

Cllr Bartholomew requested that agenda item 7.1 was brought forward for

discussion with Cllr Meyer. The advertisement in the Hexagon for the continuing activities of the Walsham 200 Club was raised. The ad appeared to publicise different beneficiaries to those originally advertised by the promoters including the removal of Play Area amongst these. Concerns were raised by Parish Councillors about how this cash draw is being run and if it was licenced. Cllr Meyer was under the impression that the scheme had no licence with MSDC. Cllr Meyer to confirm and ask for advice from the licencing authority if that is the case.





A TIME TO REMEMBER

November is very much a time to remember, whether we regard ourselves as people of faith or otherwise. The month begins on the 1st with a celebration of 'All Saints,' and continues upon the 2nd with a time to remember those who have been known to us and whom we see no more; 'All Souls Day.'

St Mary's Church Walsham will be holding a short service on the 2nd at 7.00pm when we take time to remember all those we have loved and lost, and if you are not attending but would appreciate a candle lit and a name(s) read out, please do forward onto me.

This year there will be no Services of Remembrance within our churches across the Benefice, but will be restricted to short Acts of Remembrance around the respective War Memorials; here in Walsham at 10.50am on the 8th November.

On Wednesday 11th November – Armistice Day – there will be a shortened communion service in church at 10.30am which will end with the two minute silence around the War Memorial at 11.00am, when it is hoped that pupils from the school will be able to attend.

Amongst the many and varied saints and martyrs the Church remembers during the month of November, is East Anglia's 'own son' St Edmund; whose Feast Day falls upon the 20th of November. Information regarding Edmund is somewhat vague, but we know he was born around 840, and at the age of 15 became King of the East Angles.

Details of his reign are rather scanty, but it is said that he retired to Hunstanton for twelve months to learn the 150 psalms by heart! But how much of this is down to wishful thinking of a later monastic chronicler is hard to discern.

Edmund was however clearly a Christian, and in the late 9th Century repulsed various attacks from Danish pagan invaders. Finally, overwhelming numbers defeated Edmunds army, somewhere near Hoxne on the Norfolk/Suffolk border. Because of his Christian faith, Edmund would not accept the terms of surrender, was subsequently beaten, used for archery practice and then beheaded. Legend has it that when his followers searched for Edmund's body, his head was being guarded by a wolf. Hence in many churches across Suffolk there are carvings depicting the legendary wolf; such as can be seen in St Mary's Church here in Walsham.

In the tenth century Edmund's bones were moved to Beodricsworth, later to become Bury St Edmunds, and the Abbey built there became a place of pilgrimage. From 1914 it became the Cathedral City for the newly created Diocese of St Edmundsbury and Ipswich, of which we are a part.

November is a period of reflection, and sometimes we need to stop and reflect that in our Covid dominated world, there is more to life than this present moment, that things will change and we will see a new creation. Until then we simply need to share with each other the joys and tears of our common humanity and remember with thankfulness those who have gone before us and ensured that we can take forward the message of hope for our world.

SHINE A LIGHT FOR CHRISTMAS

Ever since the star of Bethlehem led thee wise men to the baby Jesus, Christmas has been associated with light and for centuries candles were lit as part of the Christmas celebrations.

The Christmas tree tradition of putting lit candles on yew branches or trees was already established in Germany by the 16th century. Legend has it that Martin Luther, the German Protestant reformer, began the tradition of putting candles on the Christmas tree. The legend says that one December night in 1536 he was walking through a pine forest near his home in Wittenberg when he looked up and saw thousands of stars glinting jewel like through the sparkling snow covered branches of the pine trees. The beauty of this sight inspired him to set up a little fir tree at home so that he could share this story with his children. He decorated it with candles in honour of Christ's birth.

By 1605, decorated Christmas trees had made their appearance across Southern Germany and that year it is reported that the inhabitants of Strasburg "set up fir trees in their parlours and hung thereon roses cut out of many coloured paper, apples, wafers, gold foil and sweets".

Prince Albert is usually credited with having introduced the Christmas tree to this country in 1840, however, it was actually Queen Charlotte the German wife of George III, who set up the first known English Christmas tree at Queen's Lodge, Windsor in December 1800. Prior to this she had introduced the German tradition of decorating and lighting with candles a yew branch. Christmas trees as we know them quickly became all the rage in upper-class circles and were the focal point of Christmas celebrations. They were usually candle- lit, adorned with trinkets and surrounded by presents. Tabletop trees would often have painted wooden animals set out amongst the presents for extra allure. It was reported in 1804 that Frederick, the Fifth Earl of Bristol had a fantastic Christmas tree for his children at Ickworth Lodge in Suffolk. But it was Prince Albert who made Christmas trees popular with the masses by allowing drawings and descriptions of the royal Christmas trees to be published in the Illustrated London News and The Graphic so that everybody could see and read about these lavishly decorated trees. By 1860 most well-off families had a Christmas tree and any Christmas parties held for poor children would have a decorated tree as its main attraction with presents underneath.

Trees at this time were still candle-lit and this could be hazardous as even I can vouch for. I can just about remember as a small child my father putting candles on the Christmas tree. It was the early fifties and Christmas decorations and lights were still unavailable after the war. Inevitably a candle must have fallen out of its holder and caught the tree alight. Fortunately, my father was onto it quickly, the fire extinguished and the Christmas tree survived!

It was Edward H Johnson, Vice president of the Edison Electric Light Company who on the 22nd December 1882 first displayed his Christmas tree with 80 red, white and blue electric lights. This was the first time a Christmas tree had been illuminated with electric

lights. The idea quickly spread giving us the present December tradition when trees, public buildings, towns, shopping centres and our homes are illuminated with twinkling, dazzling and flashing lights to celebrate Christmas.

Light has always been a symbol of hope and during this time more than ever we need to believe and hope for a better future. Some of us may not be able to have the Christmas we usually enjoy with family and friends this year, so our village community is more important than ever. The village Christmas Tree will be lit as usual outside St Mary's and many of us will put up outside lights that we can all enjoy. It would make the village a special place to be if we could all shine a light for Christmas. It doesn't have to be outdoor lights although that would be wonderful, it could be your Christmas tree in the window, a candle arch or lantern, there are lots of battery lights available too. Just shine a light from your house during December as a sign of hope! Let us see if we can light up the whole village for December. How lovely that would look!

A PLEA FOR LANDLORDS

A Plea for Landlords is the title of an article by John Martineau published in Blackwoods Magazine in 1888. It was a time of severe agricultural depression which had started in 1873. The advent of the reaper-binder and the railroads in America, coupled with larger steam ships meant that the price of British corn collapsed. He wrote:

There is hardly a county in England at the present moment where land is not, in larger or smaller quantities, actually going out of cultivation for want of someone who will cultivate it......In many places land has been sold, or failed to find a purchaser, at less than half the value it fetched ten years ago.....

For ten years passed, at least, we have heard on all sides of abatements of rent, of households reduced, of a London season given up, of hunters exchanged for plough horses, and of big houses being half shut up and the owner living in a few rooms. Only within the last one or two years have we heard that farm labourer's wages being materially reduced......

Other businesses paid better if carried on on a large scale, and why not farming? Large fields were easier to plough by steam, and large farmers could afford to pay for machinery......

But when the depression of the land and the bad times came, somehow it was the small modest old fashioned farmers, not the new large ones, as a rule, that weathered the storm best. Many a thousand acres is now untenanted, for which there would have been applicants had the land being left in small holdings as it once was. But it is too late now; the old buildings are pulled down, the old fences grubbed...... It is the thrift in small matters that personal labour of the farmer and his family, the constant supervision of the work on the farm, that turns the scale and makes the difference between profit and loss.

The best labourers will not stay where they are where they are not well housed, and landlord and tenant will both suffer in the long run if they let them go..... And let not any one think it is superfluous and unpractical to make them shapely and architecturally interesting, as well as comfortable...... The brightness of many a labourer's life depends in no insignificant degree, on the form and appropriateness of his surroundings......

Those oak trees in the old hedgerow, still more those ashes, which send their roots forty or fifty yards close to the surface of the ground, spoil an acre or more of the crop, and shade and injure perhaps half an acre more. The tenant will complain that they do him $\pounds 5$ a year damage. If it be so, let the rent come down, not the trees. You could spend $\pounds 100$ on the picture which means paying $\pounds 4$ or $\pounds 5$ a year for it, you can subscribe to the peoples palace or picture gallery, or to the ghastly painted window which shuts out from the church the view of the soft foliage of the churchyard trees. Can you not afford $\pounds 5$ a year for a picture more beautiful, more seen and enjoyed, than any painted by human hands......

A Promised Return

The Republic of the Philippines is a group of seven thousand one hundred and seven islands in the western Pacific Ocean. On the main island of Luzon, one of the major roads out of Manila is named the MacArthur Highway in memory of an American General, Douglas MacArthur, in recognition of all that he did to defend the Philippines and its people during the Second World War. In 1942 General MacArthur was driven out of the Philippines by a Japanese attack and, after reaching Australia, on 20th March 1942 he stood on the railway station in the small town of Terowie and made a speech containing one of the famous statements of World War II. His promise to the Filipino people was, "I came out of Bataan and I shall return". Bataan was a region in the Philippines and MacArthur was promising to return to those islands and liberate them. There were many difficulties to be overcome but on 20th October 1944 he kept his promise, wading ashore at Leyte Gulf. There he made another speech, declaring, "People of the Philippines, I have returned. By the grace of Almighty God...". MacArthur had kept his word and returned to liberate the Filipino people.

On the eve of the Crucifixion, when Christ was in the upper room with his disciples, he said, "I will come again" (John 14:3). We can be very sure that this promise will be kept. The fact that the Lord Jesus Christ is coming again is repeated over and over again in the Scriptures - in fact it is one of the most prominent truths in the Bible. According to one source, there are some one thousand eight hundred and fifty-four references to the Second Coming in the Old Testament and three hundred and eighteen references in the New Testament. One out of every thirty verses in the New Testament speaks of this subject and for every prophecy on the First Coming of Christ, there are eight on Christ's Second Coming. It is absolutely certain that Jesus Christ is coming again - just as He came the first time, so He will the second; personally, and visibly (Acts 1:11). In the light of this great certainty, the most important thing for you is to be prepared for Christ's return by receiving Him as your personal Saviour.

When He returns will you bow before Him as your Saviour or your Judge?

I will come again (John 14:3)

IRISH COLLEEN CELEBRATES HER CENTURY

Born within the sound of the sea near Dundrum Bay and in sight of the magnificent Mourne Mountains, she was one of seven children brought up on the Gordon's family farm, built in the 1700s by their Scottish ancestors, 'Drumaness' at Ballykinler near Ballynahinch. Educated at Belfast High School, she trained in office work and was recruited by the War Office in Belfast to assist in the Transport Division with the organization of troop movements. This included dealing with regular groups of D Day recruits who arrived to be trained in the use of machine guns and small arms under Sergeant Whatling of the Suffolk Regiment and later the Queens Royal Regiment. He had previously worked as a heavy horseman on a farm at Acton near Sudbury.

A romance blossomed and in 1946 this Irish colleen married the Suffolk soldier, living first in Acton before moving to Badwell Ash where the Symonds family of Shackerland Hall offered employment with heavy horses in the 1950s. By 1963 horses were being replaced by tractors and the horseman and his family had to leave their tied cottage. He found new employment at the Bacon Factory in Elmswell while his wife helped Mack and Ruby Pratt in the Norwich Ale Stores at Badwell Ash before being taken on as Nanny to their youngest son Richard. He came to regard his Nanny as a second mother, spending a great deal of time in Walsham, sleepovers often, when the Whatlings moved into number 25 Grove Park. Richard Pratt , as we know, now runs his construction company based on the edge of Walsham in Summer Road.

Sadly Ernie Whatling died before he could fully enjoy a well earned retirement but his wife continued to live a full life in the Walsham community. There was a deep and long lasting friendship with Betty Jordan. They shared the distribution of the Walsham Observer in Grove Park. She was always a keen local shopper with a love of reading, knitting, music and listening to the radio. Her family is very important to her, her son Fergus living in Elmswell, visits to Drumaness and receiving return visits are all greatly valued. This depth of family feeling is reflected by Fergus having a second name of Gordon from his mother's maiden name. Fergus is really short for Ferguson and links in to Aunt Aggie who married Jim Ferguson, related to Harry Ferguson, the tractor man, who developed hydraulic systems for the Ferguson tractor which are still in use today.



APPLE CAKE FROM HAWKEDON

Mix 250g of demerara sugar 250g of raisins 375g of self raising flour 1 teaspoon of cinnamon


Add 250g of peeled, chopped apples 2 eggs whisked 200g of melted butter If the mixture is very stiff, loosen with a little milk.

Prepare a 9" by 2 $\frac{1}{2}$ " loose bottomed cake tin lined with butter or baking paper. Add the cake mixture and sprinkle the top generously with demerara sugar.

Bake at Gas Mark 3 for 1 ½ hours, but test with a skewer before removing from the

oven.

HEDGEHOGS AND BONFIRES

With bonfire night and Halloween fast approaching, the British Hedgehog Preservation Society (BHPS) is urging people to build bonfires on the day they are to be lit to save hedgehogs and other wildlife from appalling suffering.


This will not only save wildlife from burning to death but will also stop the bonfire from getting soaked should it rain the night before! Fay Vass, Chief Executive of BHPS, said "If material is stored on open ground in advance of having a bonfire, it's crucial to dismantle it and move it to another spot just before lighting. Ensure it's moved to clear ground – never on top of a pile of leaves as there could be a hedgehog underneath, and not too close to pampas grass which can ignite very easily and is another favourite spot for hedgehogs to hide under."

If a large bonfire must be built in advance, protect it whilst building by putting some chicken wire, at least one-metre-high, all the way around the bottom. This should be held in place with stakes and the wire should slope outwards at an angle to make it difficult to climb, as hedgehogs are good climbers! In case you have missed anything light the fire from one side only and keep people away from the unlit side so that any hedgehogs can hopefully escape in peace.

If, whilst building, a bonfire is left unattended, for however short a time, it's imperative to check for young children, hedgehogs and other animals, including family pets, before lighting. As hedgehogs tend to hide in the centre and bottom two feet of the bonfire, check by gently lifting the bonfire section by section with a pole or broom. Never use a spade or fork as these can stab them. Using a torch will help to see and listen for a hissing sound, as this is the noise they make when disturbed. Fay continues "If hedgehogs are found, take as much of the nest as you can and place them in a high-sided cardboard or plastic box with plenty of newspaper/old towelling. Ensure there are air holes in the lid and that the lid is secured firmly to the box, as hedgehogs are great climbers. Wear garden gloves so as not to get human smells on them and to keep them calm as hedgehogs are easily stressed – also, it protects your hands from their spikes. Put the box in a safe quiet place such as a shed or garage well away from the festivities, offer specialist hedgehog food, meaty cat or dog food and water. Once the bonfire is totally dampened down, release the hedgehog under a hedge, bush or behind a stack of logs."
