New Highways Contract Awarded - Milestone Infrastructure, part of M Group Services, has been awarded Suffolk's new highways services contract, which will begin on 1 October 2023 for up to 20 years. Following an extensive procurement exercise. The new partnership is worth around £800 million - £1 billion and will deliver highway projects and improvements across Suffolk, including maintaining roads, pavements and rights of way, drainage, hedge trimming, construction of new road schemes, snow-clearing and gritting. Street lighting is awarded separately.

Secondary School Places – This year, we received 8,083 applications from parents and carers by the closing date for admission into Year 7 in September 2023, over 300 more applications than last year. Of these: 93% (7,521) of applicants received offers for their first preference school; and 98% (7,903) of applicants received an offer for one of their three preferred schools.

Budget for 2023/24 Approved - The £687.6m package was approved at a Full Council meeting on Thursday 9 February 2023. In an online survey, Suffolk residents would like to see more spent on adult services and children's services, and these areas will receive an additional £35.7m and £13.5m, respectively. The 9.6% increase will be funded by a 3.99% increase in Council Tax (1.99% general tax and 2.00% adult social care).

West Suffolk Archives to move – Cabinet has approved moving the West Suffolk Archives from its present site on Raingate St. to West Suffolk Council's new development at Western Way in Bury St Edmunds in autumn 2025. The move follows consultation and assessment of several options, it will increase accessibility and storage, and improve links with W. Suffolk College.
